"A Colonizing Peace: The Quaker Struggle for Gospel Order in Early America," Book manuscript in progress

Abstract: In early Pennsylvania, Quaker peace practices, which they called "gospel order," perpetuated the expansion of slavery and colonization in the mid-Atlantic frontier, even as Friends struggled to rid themselves of moral and spiritual corruptions, which they saw as the root cause of violence. A key part of my book examines how indigenous peacemaking and African-American struggles for freedom inspired Quaker reform and abolitionism in the mid-eighteenth century, before the advent of modern humanitarianism.
